DIRECTIONS

FROM G.W. BRIDGE

Rt. 80 West to Exit 56 Paterson/West Paterson Bear right off exit. Make 1st left. Go through light and over bridge. At light, turn right onto Totowa Road. Go down about 1 mile. JFK High School is on right.

FROM MANHATTAN

Lincoln Tunnel to Rt. 3 West to Rt 46 West. Get off Union Blvd. Totowa Exit. Bear right. Pass 6 traffic lights. You will pass Dunkin Donuts on left. Turn right onto Don Bosco Ave. Go straight to end and JFK High School will be in front of you.

FROM NJ PARKWAY

Get off Rt. 3 West exit. Rt.3 turns into Rt. 46 W. Get off Union Blvd Totowa Exit. Bear right & after 6 lights make right onto Don Bosco Ave. Go down to end and school is straight ahead.

FROM ROUTE 46 EAST/WEST

Get off Union Blvd Totowa Exit. Bear right & after 6 lights turn right onto Don Bosco Ave. Go down to end and high school is straight ahead.

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
2. Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
